Background

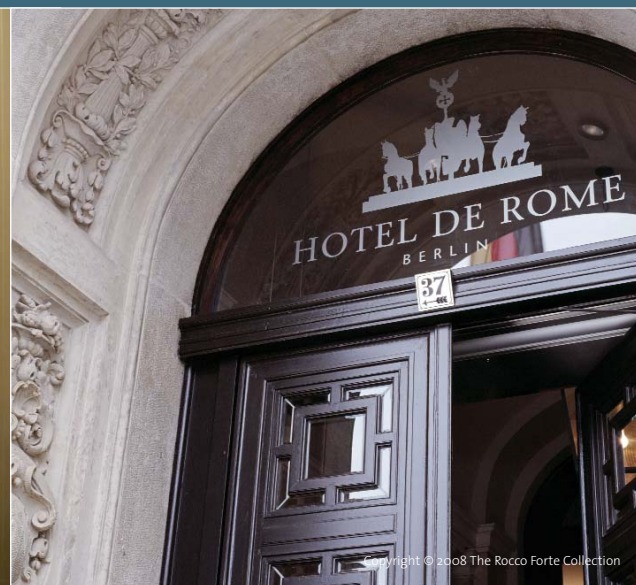

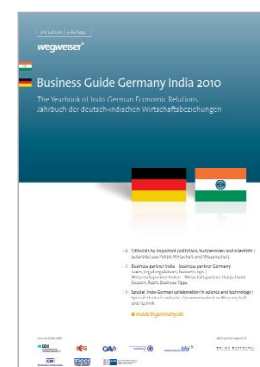
